This Supplement is prepared in connection with the €6,000,000,000 Euro Medium Term Note Programme (the "Programme") established by Statkraft AS (the "Issuer").

This Supplement is a supplement to the offering circular dated 22 March 2018 (the "Offering Circular"). The Offering Circular constitutes a base prospectus and the Supplement constitutes a supplementary prospectus for the purposes of Section 87G of the Financial Services and Markets Act 2000 (the "FSMA"). This Supplement should be read in conjunction with the Offering Circular and any other supplements issued by the Issuer. Terms defined in the Offering Circular have the same meaning when used in this Supplement.

The Issuer accepts responsibility for the information contained in this Supplement. To the best of the knowledge of the Issuer (having taken all reasonable care to ensure that such is the case) the information contained in this Supplement is in accordance with the facts as at the date of this Supplement and does not omit anything likely to affect the import of such information.

PURPOSE

The purpose of this Supplement is to:

- 1. incorporate by reference into the Offering Circular the Issuer's consolidated un-audited interim financial statements for the third quarter ended 30 September 2018;
- 2. incorporate by reference into the Offering Circular the Issuer's Notice 28 November 2018 (as defined below); and
- notify the appoint of Statkraft UK Limited (company number: 05742795, registered office: 41 Moorgate, London, EC2R 6PP) as agent for service of process for the Issuer in connection with the Programme and the retirement of Innovation Norway as agent for service of process for the Issuer in connection with the Programme, in each case effective on and from 31 December 2018.

DOCUMENTS INCORPORATED BY REFERENCE

By virtue of this Supplement, the Issuer incorporates by reference the Issuer's consolidated un-audited interim financial statements for the third quarter ended 30 September 2018 (which appear on pages 16-32 of the Interim Report Q3/2018 published on 25 October 2018).

Copies of the Statkraft AS Interim Report Q3/2018, which includes those interim financial statements, have been filed with the Financial Conduct Authority (the "FCA") through the National Storage Mechanism. By virtue of this Supplement, those interim financial statements are incorporated in, and form part of, the Offering Circular. The remainder of the Interim Report Q3/2018 is not relevant for investors or is covered elsewhere in the Offering Circular.

By virtue of this Supplement, the Issuer incorporates by reference the notice published by the Issuer on 28 November 2018 (the "Notice 28 November 2018"), entitled "Statkraft signs credit rating agreement with Fitch". Copies of the Notice 28 November 2018 have been filed with the FCA through the National Storage Mechanism. By virtue of this Supplement, the Notice 28 November 2018 is incorporated in, and forms part of the Offering Circular.

Copies of documents incorporated by reference in the Offering Circular can be obtained from the registered office of the Issuer and from the specified offices of the Paying Agent for the time being in London, as described on page 22 of the Offering Circular.
